## TASK DESCRIPTION

The Human Rights Topic test will consist of 10 Multiple Choice and 10 Short answer questions. <u>The Topic Test will be sourced from all dot points in the Human Rights Topic and include a question</u> <u>that addresses a contemporary Human Rights issue</u>
