## Orange High School Health Promotion – Assessment Task



### Assessment Outline

Today we are faced with many choices, all of which affect our health in some way, sometimes positively and sometimes negatively. When our choices are positive, we reap the rewards of improved quality of life. If our choices are negative, we suffer from poor health related issues. Health Promotion exists to educate people in an attempt to improve decision-making and minimise their risk taking behaviour regarding health issues. By achieving this, the health of the population can improve one person at a time.

For your assessment, you are required to complete the following 2 sections.

### **Part A – Identifying the influences on a specific youth-related health issue.**

Choose a **specific youth-related health issue prevalent in Orange and provide evidence** to support your choice (newspaper article, council meeting minutes, local news segment). Explain how the range of influences (such as individual, socio-cultural, economic and environmental.) can impact on an individual's ability to behave in healthy and safe ways.

### **Part B – Proposing a Health Promotion strategy to address a local need.**

Write an email to Orange City Councillor for youth and communities services. In your email, identify a specific health issue that you feel is prevalent for Orange's youth and present a health promotion strategy to address it.

Your email is to include the following:

- i) An opening greeting and some information about yourself.
- ii) A description of what you are studying in PDHPE at Orange High School and why you are sending this email
- iii) A description of your specific health issue and why you believe it to be an issue for youths in Orange. Use of any data or examples would be beneficial in this section (Newspaper article etc.)
- iv) A detailed description of your health promotion strategy. This is to include what it is, how it would be implemented (individual and community strategies) and anticipated exposure and impact on the youths of Orange.
- v) Justify your Health Promotion strategy. In other words, explain why you think it would be effective.
- vi) Thank the Councillor for their time and sign off.
