#### Assessment Outline

You are required to thoroughly research and create <u>two</u> double sided pages of comprehensive notes. You must include a minimum of two media articles, maximum four, that relate to your selected law reform issue, ensure that you link the articles clearly to your research. The research report or media file need to address the following syllabus points:

- Identify and investigate a contemporary law reform issue.
- Examine the conditions that give rise to the need for law reform, the agencies of reform and mechanisms of reform.
- Assess the effectiveness of law reform in achieving just outcomes with regard to a contemporary law reform issue.

Contemporary law reform issues you may select include;

- Young Drivers and the Law.
- Sport and the Law.
- Animal Welfare.
- Drug Use and the Law.
- Domestic violence.
- Technology i.e. Cyber bullying, Doxxing and Sexting.

**NOTE:** Native title is to be examined in class so is **NOT** to be included as a law reform issue within this assessment.

### Ensure you include the following:

- 2-4 Media articles that relate to your Law reform Issue -Use the attached template to summarise your media article.

\*Your research will need to be a maximum of 4 A4 pages (not including the articles). Remember to link the articles to your research topic.

A bibliography in a formal style of referencing will need to be attached to your notes and handed in before 9am in the library.

Non-completion of Task:

If you know you are going to be away on the day that the task is due, you must make alternative arrangements with your teacher beforehand. If you are suddenly away on the day that the task is due, you must contact your teacher or Head Teacher on your return to school. Documentation will be required.
